

Consent Form – Privacy and Personal Data Protection ROG.e 2026

Effective as of May 18, 2026.

This Privacy Statement applies to the services provided by the Brazilian Institute of Oil and Gas – IBP, a non-profit association registered under CNPJ No. 33.634.254/0001-10, headquartered at Av. Almirante Barroso, No. 52, 21st and 26th floors, Rio de Janeiro – RJ, ZIP Code: 20.031-918, through the ROG.e 2026 sales platform.

This Privacy Statement aims to demonstrate, with full transparency, our privacy practices regarding the activities described herein. Please read it carefully to understand how we collect, use, share, and process personal data, as well as to learn about your rights and choices regarding your Personal Data.

This document has been prepared in accordance with the General Data Protection Law (Law No. 13,709/18), the Brazilian Civil Rights Framework for the Internet (Law No. 12,965/14), and the EU Regulation No. 2016/679. This document may be updated due to regulatory changes or to reflect updates in our practices, technologies, legal requirements, or other factors. If we make substantial updates, we may notify you, for example, by placing a prominent notice on our website or by contacting you directly.

IBP and ROG.e 2026

IBP is an institutional representative of the oil and gas sector, with over 62 years of activity dedicated to developing a competitive and sustainable industry, generating widely recognized benefits for society.

One of its initiatives is ROG.e 2026, which will take place from September 21 to 24, 2026, in a fully in-person format. The event will feature four (4) days of programming, including discussions on environmental, social, and governance aspects, from the perspective of investment attraction, project financing, and the regulatory framework of oversight and financial bodies in Brazil.

IBP acts as the controller of your Personal Data, as described in this Privacy Statement, unless otherwise specified.

1. Covered Processing Activities

This Privacy Statement applies to the processing of Personal Data carried out by IBP in relation to ROG.e 2026, collected when you:

- Interact with platform pages that display a link to this Privacy Statement;
- Visit our social media profiles;
- Receive our communications, including emails, phone calls, text messages, or chat messages;
- Register for and participate in ROG.e 2026, including congress sessions, exhibitions, and satisfaction surveys;

- Make payments for paid services related to ROG.e 2026;
- Complete accreditation and access the event, including through facial recognition systems involving the collection and processing of biometric data (facial biometrics), when applicable.

Our websites and services may include links to third-party websites, applications, and services. The privacy practices of such third parties are governed by their own privacy statements.

2. What Personal Data Do We Collect?

The Personal Data we collect includes identifiers, professional information, commercial information, visual data, and internet activity data. We collect this information when:

- You express interest in our services;
- You register for the event (e.g., name, job title, company, address, phone number, email, username, areas of interest);
- You create login credentials for access to restricted platform areas;
- You purchase paid services (billing and payment data);
- You register in online communities;
- You interact with our websites or emails (e.g., IP address, browsing behavior via cookies);
- You voluntarily submit information (e.g., surveys).

Additional data collection includes:

- Newsletter subscription (email stored until unsubscribe request);
- Biometric data (facial recognition) for accreditation, access control, and security.

3. Use of Cookies

Cookies are small text files stored on your device to ensure proper website functionality and provide usage insights.

We use cookies to analyze navigation data, improve user experience, and offer personalized services. Users may disable cookies via browser settings, although this may impact certain functionalities.

4. Purposes and Legal Bases for Processing Personal Data

We process your Personal Data for the following purposes:

- Providing services and platform access (legal basis: contract performance – LGPD art. 7, V);
- Managing payments (LGPD art. 7, V and X);
- Sending offers and communications (legitimate interest – LGPD art. 7, IX);
- Ensuring platform security (LGPD art. 7, IX);

- Handling support requests (LGPD art. 7, V and IX);
- Complying with legal obligations (LGPD art. 7, II);
- Protecting rights and preventing misuse (LGPD art. 7, VI and IX).

4.1 Sensitive Personal Data

Sensitive data (e.g., gender identity, race, disability) may be collected for diversity, inclusion, and accessibility purposes, based on consent (LGPD art. 11, I).

Biometric data (facial recognition) may be used for identity verification and security (LGPD art. 11, II, “g”).

5. Data Sharing

IBP may share Personal Data with service providers, partners, and exhibitors (with your consent), for operational, legal, and service-related purposes.

6. International Data Transfers

Your Personal Data may be transferred to other countries, provided adequate data protection standards equivalent to Brazilian law are ensured.

7. Children and Adolescents

The event is not intended for minors. We do not knowingly collect data from children or adolescents.

8. Data Retention

Personal Data is retained for as long as necessary to fulfill the purposes described or comply with legal obligations. After this period, data will be deleted or anonymized.

9. Your Rights

You have the right to:

- Access your data;
- Correct inaccuracies;
- Request deletion;
- Request data portability;
- Withdraw consent;
- Object to processing;
- Request review of automated decisions.
